Barry Atchison nominated Todd Berkey for President Pro Tem. Dave Weimer seconded the motion and the motion carried.

The motion was made by Donald Warrick to appoint Barry Atchison to be the Borough's representative to the Somerset County Co-Op. Amy Jo Stout seconded the motion and the motion carried.
